No Manual record maintained centrally, hence verification was difficult.</p>	<p><u>Rectified.</u></p> <p>Six computerized OPD registration counters are working simultaneously at Central Registration to cater large patient flow and hence it is not feasible to enter the record of all the OPD patients manually in one Central Register.</p> <p>However, as per MCI's instructions cited below, the manual record is maintained in the respective departmental OPD registers which were duly verified by the assessor on the day of assessment.</p> <p>The MCI's instructions at point no. 5 under the heading 'Infrastructure' on page no. 7 of the Assessor's Guide 2019-2020 are reproduced in verbatim as under:</p> <p><i>"5. 



4	<p>Male surgical ward, 8 beds were vacant, deficiency not rectified.</p>	<p><u>Rectified.</u></p> <p>Non occupancy of 8 beds in Male Surgical Ward cannot be considered as deficiency, as these beds are occupied only when the number of admitted patients in surgery exceeds 112. Since the number of patients was less than 112 out of 120 who were accommodated in main surgical wards, as such remaining beds remained unoccupied. It had already been explained in our reply before Hearing Committee held on 15.05.2018 and the explanation was found to be satisfactory.</p> <p>The matter was also communicated to MCI earlier vide letter no. IIMSR/DO/2018/1317 dated 08.09.2018 (Annexure-5) and was also presented before Secretary General, BOG in the meeting held on 03.12.2018. 

(Annexure- 7)</p> <p>For Paediatrics, as per MSR, only one Demo Room is required which is available and was verified by the assessor on the day of inspection. (Annexure-8)</p> <p>The above details were submitted before the Hearing Committee which was accepted and has already been found to be satisfactory by the hearing committee.</p> <p>However, now these demo rooms have been shifted on the respective floors of Hospital Block alongside respective wards.</p> <p>Photographs of the Demo Rooms are annexed. - (d) Excess/Extra teaching faculty of any department cannot compensate the deficiency of any teaching faculty in any other department.
